- Context and dynamics of bilateral, regional, and multilateral treaty making skills and techniques of drafting.
- Drafting EPA agreements
- Infusing Non-Discrimination in trade agreements; Infusing other basic principles of international trade in trade agreements.
- Professional responsibilities of the drafter; treaty-interpretation in international law.
- Principles of Treaty Interpretation (Vienna Convention on the Law of Treaties (VCLT), Rules and methods of treaty interpretation; Role of context and subsequent practice in interpretation)
- trends in treaty-making; mock drafting and interpretation exercises.
- Implementation and Application of Treaties (Case studies of interpretation of trade agreement by the Panels of the Dispute Settlement Body, the Appellate Body and other international courts and tribunal).
- Monitoring and enforcement mechanisms.

- Workshops focusing on treaty drafting exercises.
- Guest lectures by legal experts in international treaty law.
